If parking on the street, please use residence & neighbors grass parkway or across the street in the neighbor's dirt parkway – just be careful of the plants.

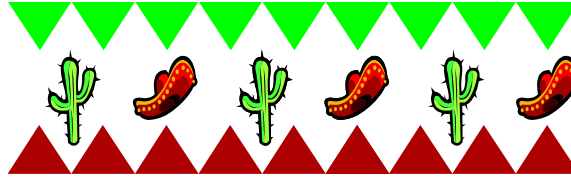
Show will be in grass pasture behind horse corrals.

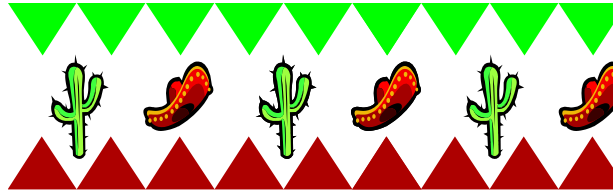

**DIRECTIONS TO SHOW:**

From I-10 eastbound, take 60 East. Exit Greenfield Rd., go right or South on Greenfield. Left or East on Elliot Rd. Take 1<sup>st</sup> Right on Sawyer Lane (after signal).

From I-10 westbound take Loop 202 East. Exit Higley Rd., go left or North on Higley. Left on Elliot Rd. Left on Sawyer Lane (where grass center median ends)

*Then follow the 2 curves and continue down S. 163<sup>rd</sup> St. almost to end of street. House on left with a GSD address sign.*
